Stock research service for smaller and/or foreign companies

Aktieinfo offers a unique service to foreign and/or smaller stock-listed companies - stock market research reports in Danish. The idea is to attract and help investors to overlook the company as part of the investment decision process. We operate on a free basis but the cost is paid by the company as part of normal investor services. Of course you as a client will oversee the report and may come up with input to get all information and investment ideas handled as correct and prudent as possible.

We offer three setups:

LIGHT: Once a year, normally based on your Annual Report. Price DKK 20.000,-.

MEDIUM: Twice a year, normally based on Semi- and Annual Reports. Price DKK 30.000,-.

PRO: Four annual reports based on your reporting through the year. Price DKK 40.000,-.

The size of the Stock Report is normally 4-5 pages. We descripe your company as well as products and services. This is important in order to understand the business you are conducting. By reviewing the products, services and the financial figures, we describe important positive and negative factors in relation to your company. This ends up in a conclusion of the future potential for the company and thereby also an investment idea on the stock. This is of course made in balance to the actual stock price and the market outlook in general. The Stock Report holds a recommendation with a target for the stock price in a short (0 to 6 months) and longer (12 to 18 months) perspective.

General information about a cooperation:

- The reports are made in Danish
- All prices are excluding Danish VAT.
- We send the Stock Report to you as a draft in order for you to make comments and if necessary give us further input. After your acceptance the Stock Report is being published on our webpage, which is seen by many Danish investors. The Report is given to a number of Danish newsmedia in order to get public attention. The Report is also being mentioned in our newsletter, which is sent out to +2.900 persons.
- The Stock Reports are being produced in a high quality on the basis of all available public information on your webpage and in the financial reports. General economic and market data are also part of this.
- You hold all rights to use and distribute the Stock Report at your own discretion, for instance by uploading the Report on your webpage or by handing out the Report as part of investor events. You are also free to translate the Report into other languages. All rights belong to you.
- Aktieinfo and its employees are obliged in the document to inform on eventual holding of shares in your company.
